3. Please note that revised schedule of tariff attached to the decision as Annex-I is required to be notified in the official Gazette.

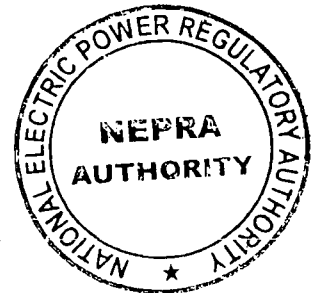


**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT OF THE ENERGY CHARGE PART OF THE TARIFF RELATING TO FUEL FOR JAMSHORO POWER COMPANY LTD. (JPCL)**
