3. Please note that revised schedule of tariff attached to the decision as Annex-I is required to be notified in the official Gazette.

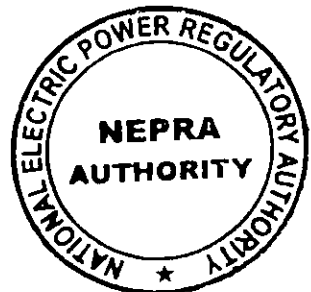




Pursuant to paragraph 18 of the Authority's decision dated July 02, 2007 in respect of generation tariff for Jamshoro Power Company Ltd. (JPCL), adjustments have been made in the fuel part of energy charge subsequent to change in furnace oil prices with effect from ~~31~~ August 2010. The block-wise revised fuel cost component for JPCL is indicated hereunder:


