
Pursuant to the decision of the Authority dated 26th August 2011 in the matter of adjustment at commercial operation date on HSD and mixed fuel operations, on the basis of information provided by EPQL, the insurance component of capacity charge part of tariff on HSD and mixed fuel operation of EPQL has been revised on the basis of actual insurance premium of Rs. 123.3285 million in accordance with the Schedule VIII of the Power Purchase Agreement (PPA). The revised insurance component of capacity charge part of tariff on HSD and mixed fuel operation indicated hereunder shall be immediately applicable:





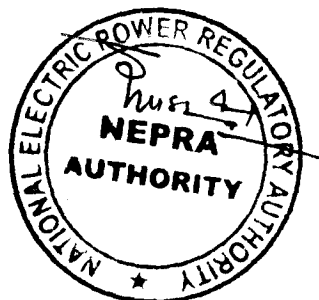
