NOTICE OF HEARING

PETITION FILED BY BAHRIA TOWN (PVT) LTD. (BTPL) RAWALPINDI FOR DETERMINATION OF CONSUMER-END TARIFF FOR THE PERIOD JULY 2014 TO JUNE 2015

All stakeholders, interested / affected persons and the general public are notified that Bahria Town (Pvt) Ltd. Rawalpindi has filed a petition with National Electric Power Regulatory Authority (NEPRA) for Determination of its Consumer-End Tariff from 01-07-2014 to 30-06-2015.

SALIENT FEATURES OF THE PETITION

1. The Petitioner, power distribution licensee (Distribution License No. 20/DL/2010 dated 24th November 2010), is a Private Limited Company incorporated under the Companies Ordinance 1984 and is principally engaged in real estate development.
2. The Authority held a public hearing on August 26, 2014 on the tariff petition filed by BTPL for Determination of its Consumer-End Tariff of FY 2014-15. The Authority has considered a tariff mechanism for BTPL which would also have a impact on other related entities. Keeping in view the importance and rationale for determination of tariff for BTPL, the Authority has framed additional issues which are necessary to be deliberated before finalization of the instant petition.
3. The additional issues are as follows:-
 - i. Whether the supply of electricity to BTPL can be procured from Central Power Procurement Agency (CPPA)?
 - ii. Whether the proposed Single Tariff Formula in place of Slab Based Tariff be introduced for BTPL consumers in existence of different slabs available to consumers of XW-DISCOs and K-Electric (KEL)? *
 - iii. Whether the proposed Single Tariff Formula covers the factor of self generation in case of load shedding by BTPL?
 - iv. Whether the terms & conditions applicable to XW-DISCOs will also be applied to BTPL?

4. Any person may file the comments in the matter within **Seven (7) days** of the publication and the Authority, if deemed fit, may permit participation of such person into the proceedings and also may consider those comments in the final determination.
5. All stakeholders and interested / affected persons are also informed that in order to arrive at a just and informed decision, the Authority decided to hold a hearing in the subject matter according to the date, time and venue as mentioned below:
