**Subject: QUARTERLY ADJUSTMENT (Q1 OF FY 2019-20) OF XWDISCOS UNDER SINGLE YEAR TARIFF (SYT) AND MULTIYEAR TARIFF (MYT) REGIME.**

Further to our letter of even no. dated November 12, 2019 and Disco's submission for quarterly adjustments of Quarter-1 for FY – 2019-20 and with reference to Federal Government motion dated November 09, 2018 under section 7, 31(4) and 31 (7) of NEPRA act 1997 read with Rule 17 of the NEPRA (Tariff Standards and Procedure) Rules, 1998 for recommendation of uniform consumer end tariff at national level, which was decided by the Authority on December 19, 2019. The uniform tariff so determined by the Authority was notified by the Federal Government vide SRO.1(I)/2019 to SRO.12(I)/2019 dated January 01, 2019. The said tariff was effective from January 01, 2019.

2. Further with reference to Federal Government guideline with regard to Methodology for incorporation of Quarterly Adjustments in the Uniform Tariff of XWDISCOs in terms of the Provisions of "Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997" (the "Act") dated April 18, 2019 which was decided by the Authority on June 14, 2019 and notified by Federal Government Vide SRO. 660(1)/2019 to SRO 669(1) 2019 Dated June 28, 2019.

3. On the same principle as earlier adopted for determination of uniform quarterly adjustment for four quarters of FY 2018-19, the quarterly adjustment of Q1 of FY 2019-20 request of XWDISCOs are attached for determining a uniform rate tariff across each category of consumer of XWDISCOs (excluding life line consumers), to be recovered in the same manner as was done for previous quarterly adjustments.

4. In view of above the Authority is requested that the impact of 1<sup>st</sup> Quarter of FY 2019-20 as requested by XWDISCOs on uniform basis may immediately be reflected in monthly bill of consumers of all XWDISCOs till its final recovery. Any excess and less adjustment would be settled between DISCOs at CPPA-G level.
