(A). Text of proposed modification

The competent authority has granted the 6.50MW generation license No. SGC/127/2018, dated September 10, 2018 to Jilani Energy (Pvt.) Limited-JEPL. The Licensee being dispersed the electricity load to following Bulk Power Consumers:

- Javaid International (Pvt) Ltd: 3.2MW
- Jilani Poly Industries (Pvt) Ltd: 2.8MW

The Licensee now plans to disperse the 6.50MW electricity load to following Bulk Power Consumers:

- Javaid International (Pvt) Ltd: 02MW
- Jilani Poly Industries (Pvt) Ltd (Unit-1): 2.8MW
- Jilani Poly Industry (Pvt) Ltd (Unit -2):1.2MW

No increase or decrease in power generation is there in proposed modification, instead only load transfer /distribution is involved in existing generation licence No. SGC/127/2018, dated September 10, 2018).

(B). Statement of reasons

In order to meet with the growing needs of company's Bulk Power Consumers [BPC(s)], the company has planned to distribute 6.50 MW power generation in its existing sister concern unit along the rout of power transmission will result slight change in power distribution as mentioned above and no increase or decrease in installed capacity, thus requiring a modification in the generation licence.

(C). A statement of the impact on the tariff, quality of service and the performance by the licensee of its obligations under the licence

The proposed sequence of distribution will not have any impact on tariff, Quality of Service and obligation of the Licensee under its Licence.
