Subject: RENEWAL/EXTENSION OF DISTRIBUTION LICENSE NO.01/DL/2001

In exercise of the power conferred upon the National Electric Power Regulatory Authority (NEPRA) under Section-26 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997) the Authority hereby granted Distribution License No. 01/DL/2001, on November 02, 2001 for 20 years to Islamabad Electric Supply Company Limited (Copy Attached).

The license is going to expire as on November 01, 2021. As per National Electric Power Regulatory Authority NEPRA Licensing Procedure Regulations, 2021 Part IV, under Rule 13 Extension or Renewal of Terms of License, the licensee shall produce the following information to the NEPRA:-

- IESCO requires the extension in Distribution License
- Proposed time period of extension is 20 year starting from November 02, 2021 to November 01 2041.
- A statement of reasons in support of the extension:
 License is going to expire as on November 01, 2001. As Licensee is operating in six operation circles having five districts with 20 operations divisions, 6 construction divisions, 4 GSO, 4 GSC and 6 M&T divisions, serving the 3,288,709 consumers of different categories. Moreover, Licensee has total no of 114 Grid Stations with total no of 52,114 Distribution Transformers having distribution capacity of 4,292 MVA over 1,035 Feeders inclusive of 114 Feeders in AJK. (Detail Attached)
 However, it is in the interest of consumers and the electric power industry as whole and it is reasonably necessary to ensure the continuous, safe and reliable supply of electric power to consumers.
- Application fee as set out in Schedule II of these regulations for Distribution Company is Rs. 2,500,000 (Draft Attached)
