ISSUANCE OF NO OBJECTION CERTIFICATE FOR TRANSFER OF

GENERATION LICENCE

NEPRA's Letter No. NEPRA/DG(Lic)/LAG-80/35228, dated August 27, 2021

Pakistan Steel has applied NEPRA to grant NOC for transfer of its Generation License (No. SGC/41/2008 dated September 25, 2008) to its own subsidiary company i.e. Steel Corp. vide letter No. No./Sec./TS-270/2021/471 dated June 25, 2021. In response NEPRA has asked PSM to get the term of generation license extended before starting any procedure of transfer vide letter No. NEPRA/DG(Lic)/LAG-80/31986, dated July 16, 2021, according to section 27 of the NEPRA Act.

- Vide our letter No. Sec/TS-270/2021/582, dated July 28, 2021, PSM due to its closure since 2015 had elaborated the impediments being faced to apply for extension of terms of its Generation License as stipulated in regulation -13 of the NEPRA, however, express its consent for renewal after revival by paying all outstanding generation license fees till date.
- 3. In spite of all elaborations, NEPRA has again asked for the renewal of license prior any other modification vide letter No. NEPRA/DG(Lic)/LAG-80/35228, dated August 27, 2021.
- In view of above all communication, PSM is applying to get its generation license No. SGC/41/2008renewed for another term. As PSM could not provide the required information as stipulated in Part VI (Extension or Renewal of Term of License) of NEPRA Licensing (Application, Modification, Extension and Cancellation) Procedure, 2021 due to a long term shut down, NEPRA is requested to renew the License considering previously declared parameters, characteristics and information because the aim of renewal is only to get NOC for transfer of license to its own subsidiary company.
- The renewal application along with the fee cheque amounting Rs. 759,720/- (Rupees Seven Hundred Fifty Nine Thousand Seven Hundred and Twenty only) calculated according to the formula given in INDEXATION for FEES of NEPRA Licensing (Application, Modification, Extension and Cancellation) Procedure, 2021 is attached here with for further action at your end, please.
