Subject: RENEWAL/EXTENSION OF DISTRIBUTION LICENSE NO. 08/DL/2001.

In exercise of power conferred upon the National Electric Power Regulatory Authority (NEPRA) under Section 26 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1977) the Authority hereby granted Distribution License No. 08/DL/2001 30th April 2002 for 20 years to Quetta Electric Supply company Limited (Copy Attached).

The license is going to expire on 30th April 2022. As per National Electric Power Regulatory Authority NEPRA Licensing Procedure Regulations, 2021 Part IV under Rule 13 Extension or Renewal of Terms of License, the licensee shall produce the following to the NEPRA:-

- QESCO requires the extension in Distribution License.
- Proposed time period of extension is 20 years starting from 30th April 2022 to 29th April 2042.
- A statement of reason in support of extension:
License is going to expire on 30th April 2022. As licensee is operating in 6 operation circles having 14 operation divisions, 3 construction divisions, 6 GSO, 4 GSC and 6 M&T divisions serving 670,667 consumers in different categories.
However it is in the interest of consumers and the electric power industry's whole and it is reasonably necessary to ensure the continuous, safe and reliable supply of electric power to consumers.
