Under the existing generation licence, we are allowed supplying to one Bulk Power Consumer (BPC) namely OmyaPack (Private) Limited. Now, we want to supply power to the tune of 3.00 MW to another BPC in the name of STARCHPACK (PRIVATE) LIMITED, located at about 01 KM from the generation facility.

(C). Statement of reasons

In order to supply to STARCHPACK (PRIVATE) LIMITED, we will be requiring an authorization from the Authority as stipulated in the Section-22 of the NEPRA Act for which a modification in the existing generation Licence is necessary. As explained above, the proposed BPC is located a distance of 01 KM from our generation facility for which an 11 KV feeder will be laid.

The Licensee is allowed to charge the Power Purchaser/BPC a mutually agreed tariff. Further, there will not be any adverse impact on the quality of service and obligation of the Licensee under its Licence.


