1. BACKGROUND -

- UEP WIND POWER (PRIVATE) LIMITED, a company duly organized and existing under the laws 1.1 of Pakistan with its registered office located at 4th Floor, Bahria Complex 1, 24 M.T. Khan Road. Karachi 74000. Pakistan (the "Project Company"). was granted a generation license no. WPGL/22/2013 (the "Generation License") for its 99 MW (installed capacity) wind power generation facility located at Jhampir, Near Nooriabad, District Thatta, Province of Sindh, Pakistan (the "Generation Facility") by the National Electric Power Regulatory Authority ("NEPRA") pursuant to the relevant provisions of the Regulation of Generation. Transmission and Distribution of Electric Power Act. 1997 (including any amendment thereto or re-enactment thereof) (the "NEPRA Act"). The Generation License was issued vide NEPRA's determination dated 04 November 2013, bearing reference no. NEPRA/R/LAG-229/2353-55. titled 'Generation Licence No. WPGL/22/2013, Licence Application No. LAG-229, UEP Wind Power (Pvt.) Limited (UEPWPPL)', which sets out the terms and conditions of the Generation License (the "Terms and Conditions") that were subsequently modified (to the extent of Schedule-I and Schedule-II of the Terms and Conditions) by NEPRA vide its determination dated 17 November 2014, bearing reference no. NEPRA/R/LAG-229/15074-79, titled 'Modification-I in Generation Licence No. WPGL/22/2013 — UEP Wind Power (Pvt.) Limited (UEPWPPL).
- 1.2 Pursuant to Article 4.1 of the Terms and Conditions (as reproduced below), the Generation License is valid for a term of twenty (20) years from the commercial operations date of the Generation Facility (the "Term of the Generation License"). Since the commercial operations date of the Generation Facility occurred on 16 June 2017, as set out in the Central Power Purchasing Agency (Guarantee) Limited's notification dated 05 July 2017, bearing reference no. Tech/DGMT-II/MT-V/UEPW/27263-81, titled 'Notification of Commercial Operations Date of the Generation License thus expires on 16 June 2037 (the "Generation License Actual Expiry Date"). However, the expiry hard date mentioned in the Generation License is 29 June 2035 (the "Generation License Expiry Hard Date") which is not consistent with the Generation License Actual Expiry Date.

Article 4.1 of the Terms and Conditions reads as follows: "The Licence is granted for a term of twenty (20) years after the COD of the generation facility/Wind Farm."

1.3 In view of the foregoing and the Project Company's letter dated 22 September 2022, bearing reference no. UEPW-PM-LT-NEPRA-024, titled 'UEP 99MW Wind Power Project – An Early Harvest CPEC Project – Request for Amendment in the Expiry Date of Generation License' issued to NEPRA, the Project Company is requesting NEPRA for a rectification in the Generation License Expiry Hard Date to make it consistent with the Generation License Actual Expiry Date under this application pursuant to Regulation 10 (Licensee Proposed Modification) of the National Electric Power Regulatory Authority Licensing (Application, Modification, Extension and Cancellation) Procedure Regulations, 2021, as may be amended or modified from time to time (the "2021 NEPRA Licensing Regulations"). Accordingly, NEPRA is requested to approve the Proposed Modification (defined in paragraph 2.2 (Text of the Proposed Modification)) in the Generation License.

2. THE LICENSEE PROPOSED MODIFICATION

2.1 <u>Type or Category of the Generation License</u>

Generation License for the construction, ownership and operations of a 99 MW (installed capacity) wind power plant.

2.2 <u>TEXT OF THE PROPOSED MODIFICATION</u>


