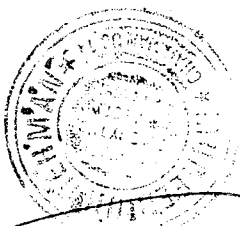

SUBJECT: COMMENTS REGARDING K-ELECTRIC'S SUPPLY PETITION

Dear Sir,

I would like to share my comments on K-Electric's application for renewal of Distribution License as I believe that being an industrialist, it is important that we put forward our thoughts as essential power sector stakeholders who want the best for the country at large.

We believe that K-Electric's license should be renewed which, in our view, would definitely work in the best interest of not just the industry of Karachi but also the residential commercial and other customers within the city. We also understand that the envisaged Competitive Trading Bilateral Contracts Market (CTBCM) model aims to provide eligible consumers to choose supplier of their choice, however, given its economics, network is perceived as a natural monopoly around the world. Some global examples can be considered as good case studies, belonging to both the developing and the developed world where it ended up becoming a win-win situation for the power sector and customers.

Right now, we need electricity tariffs (although it is regulated or determined by NEPRA) to be cost effective and regular price hikes in utility bills is the last thing we should expect because it is crushing the underprivileged (SMEs) segment of the society as well as the industrial output.

In a completely non-ideal situation, should KE license not get renewed, it will not be a loss for the company alone despite previous and current investments but that for all the power consumers and a massive one indeed, irrespective of them being industrial consumers or residential which may put security and reliability of power supply at high risk. Also, if this really were to happen, KE assets would remain its property and for any new player, a power setup from scratch would take time and power the city of over 20 million. Therefore, it is of utmost importance that an objective decision be taken and in the wake of this objectivity a non-exclusive license under the current market reforms as per the Competitive Trading Bilateral Contract Market (CTBCM) which should remain uniform throughout the country be granted to KE.


I would also like to say that there should be no parallel network in a service territory as such duplications in network would affect economies of scale and adversely impact competitiveness of small industries which could feel the pressure and be fizzled out.

Lastly, privatization is key for the power sector becoming efficient; we already have a success story in the form of KE investing PKR 474 billion since privatization and expect that it would be liberating for customers if the rest of the country followed similar suit. This could relax the circular debt and bring about relief for the national exchequer in terms of cash inflows and investments.

I hope that in light of the above discussion which may be paid heed to, NEPRA would consider opinions and suggestions of all stakeholders before passing on a decision which I am confident would be an objective one and favor the power customers of the city who are seeking relief, competition, safe and reliable supply of power, and all progress through efficiency in the sector.

Honourable Sir,

I hope you are doing well. I am writing this letter to share my thoughts regarding KE's supply license application and what in my humble opinion would be in the best interest for the energy future of Karachi.

We are an organization working with underprivileged areas of Karachi including District Kemari with a focus on development of these areas and utility service provision is an important element of this. As for KE, we have seen them make efforts to improve services despite prevailing challenges as many of the residents in these areas have low propensity to pay.

Despite many challenges, KE is finding ways to work with the community and some parts of these areas a case study because they receive uninterrupted power and it must be acknowledged that recovering bills and managing electricity theft are challenges that must be overcome for any utility company.

It is commendable that they regularly set up recovery camps to manage the issue of recoveries in an area which still has Rs. 10 billion outstanding dues, while currently there still are some areas in District Kemari which do not undergo any load shedding anymore because of their high bill payment ratio. These areas account for 38% of District Kemari.

At the same time, it is important that if KE's licenses are being renewed or extended then they should be bound to add cheaper generation to reduce the cost of electricity so that the burden on the masses can be lifted.

It is good that they are also open to competition as well which can help further improve the power supply situation in Karachi. Keeping in view KE's performance over the years, it should also require approvals to improve its services through investment and the company should share an update on the progress that they are achieving on a regular basis.

It may please be considered that organisations such as ours, which include vocational centers and hospitals look forward to a thriving ground so that the benefits can be passed on for the stakeholder

groups who find it difficult to make ends meet; for this we are reliant on KE in areas where perhaps new companies may shy away from and hence the granting of the supplier license as requested would be critical to ensure continuity of power supply.

With this, I am hopeful that NEPRA makes pragmatic decisions which will consider the best interest of organizations and electricity customers as well as their current and future needs while enabling KE to make requisite investment for the uplift of the city. Competition may take time to enter the market and eventually start serving people while initially KE will be the only supplier. Hence, we must let them serve people until new and practical options start shining above the horizon.

Reference is made to NEPRA's letter no. NEPRA/R/LAS-22/15816-23 dated 26th June 2023, wherein PPIB is requested to provide views and comments on the application filed by K-Electric (KE) for grant of power supply license.

2. PPIB comments on the application filed by KE for the grant of a power supply license, are as follows:

- a) **Power Acquisition Program (FY 2024 -FY2030) Page no. 11/30, Section 3.3 "Other Assumption"**: The applicant has requested an extension in the useful lives of their existing power plants that will expire between FY 2024 till FY 2027. The power projects rely on RFO and RLNG, which are imported commodities, making generation expensive. Considering the current economic condition of Pakistan, it is proposed that the Authority may direct the applicant to procure power from alternative, cheaper sources on an urgent basis.
- b) **Power Acquisition Program (FY 2024 -FY2030) Page no. 12/30, Section 4 "KE Proposed Power Acquisition Programme"**: The applicant plans to develop three local coal-based power plants with a capacity of 330 MWs each in FY 2026, FY 2027 and FY 2029. The applicant's proposed timelines for the development of projects may need to be revised to align with the realistic construction period of 36 months.
- c) It is recommended that, instead of developing 330 MW power plants, applicant should consider opting 660 MW local coal-based Ultra-Super critical or Super-Critical proven technology power plants to meet its network demand.
- d) The applicant claimed that the 330 MW Siddiqsons Energy Limited power plant is expected to come online in FY 2026. However, this claim seems unrealistic due to ongoing litigation and the absence of a final decision by the Honourable Court. Further, the construction period of a conventional coal power plant is 36 months, therefore timelines be rationalized.
- e) The applicant plans to add baseload power plants in FY 2026 and 2027 by developing them from scratch. Delays in project execution could lead to a potential gap in demand and Supply, so it is important to ensure the feasibility of the proposed timelines.

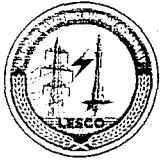
f) It is important for the applicant to maintain a balanced demand-supply ratio to avoid any potential shortage or asymmetries in the power supply. In case the applicant fails to meet the proposed targets, a contingency plan should be put in place to address the shortfall and ensure an uninterrupted power supply to consumers.

3. It is highlighted that the applicant has submitted proposals and Expressions of Interest for the procurement of power from the Jamshoro Power Project (after conversion to Thar coal) and 660 MW Lucky Electric Power Project. These proposals indicate a potential shift in the applicant's power acquisition strategy, hence it is important to provide an update in their application. Additionally, if the applicant plans to procure power from the National Grid or utilize the services of an Independent Auction Administrator (IAA), it is suggested that the applicant may approach IAA by fulfilling the necessary requirements.
