#### **DECISION**

Brief facts leading to the disposal of this appeal are that an appeal filed by Faisalabad Electric Supply Company (FESCO) against the decision dated 17.07.2014 of Provincial Office of Inspection/Electric Inspector Faisalabad Region, Faisalabad was dismissed by NEPRA on 25.02.2015. Said decision was assailed before Honourable Lahore High Court Lahore through Writ Petition No. 13470/2015 and the decision of NEPRA dated 25.02.2015 was set aside by Lahore High Court Lahore vide it's decision dated 25.04.2016 with the directions to rehear the case.


