1. As per facts of the case, the respondent, who is an industrial consumer of the appellant

FESCO bearing Ref No.24-13214-5403300 filed an application before Provincial

Office of Inspection (POI), Faisalabad Region, Faisalabad and challenged the

The matter was disposed of by POI vide its decision dated 31.05.2017, wherein the aforementioned bills were declared null and void and consequently a credit of 88,504 units/155 kW MDI was afforded to the respondent.

- 2. Through the instant appeal, POI decision dated 31.05.2017 has been disputed by FESCO. After issuing the notice, hearing of the appeal was conducted in Lahore on 18.05.2018 in which Mr. Shahzad Ahmed Bajwa advocate appeared for the appellant FESCO but no one entered the appearance for the respondent. At the outset of hearing, learned counsel for FESCO stated that the matter has been resolved inter-se the parties amicably and as such FESCO did not intend to proceed further with the appeal.
- 3. In view of above, the appeal is dismissed as withdrawn.
