

DECISION

1. As per facts of the case, Mr. Tariq Javed (hereinafter referred to as the "Appellant") is an industrial consumer of the IESCO (hereinafter referred to as the "Respondent") bearing Ref No.27-14329-4672400 with a sanctioned load of 78 kW and the applicable tariff category is B-2(b). The Appellant filed a complaint before the Provincial Office of Inspection, Islamabad Region, Islamabad (the "POI") on 21.04.2021 and challenged the detection bill of Rs.521,468/- charged by the Respondent due to 33% slowness of the meter observed during the checking dated 25.02.2021. The complaint of the Appellant was disposed of by the POI vide decision dated 01.12.2021, wherein the above detection bill was declared legal and justified.

2. Subject appeal has been filed by the Appellant against the above-referred decision of the POI (hereinafter referred to as the "impugned decision") before the NEPRA.

3. Proceedings by the Appellate Board

Upon filing of the instant appeal, a Notice dated 28.01.2022 was sent to the Respondent for filing reply/para-wise comments to the appeal within ten (10) days. However, no reply/para-wise comments were received from the Respondent.

4. Hearing

Hearing in the matter of the subject Appeal was fixed for 02.09.2022 at Islamabad and accordingly, the notices dated 26.08.2022 were issued to the parties (i.e. the Appellant and the Respondent) to attend the hearing. As per schedule, hearing of the appeal was conducted at the NEPRA Head Office Islamabad on 02.09.2022 in which learned counsels of both parties were present. At the outset of the hearing, learned counsel for the Appellant disclosed that the matter of the disputed bill was amicably settled between the parties, as such the Appellant did not want to proceed with the appeal. Learned counsel for the Appellant prayed for withdrawal of the appeal.

5. In view of the above statement of learned counsel for the Appellant, the appeal is dismissed as withdrawn.
