DECISION

- As per facts of the case, one S. M. Naqvi, being an industrial consumer of K-Electric was charged a
 detection bill of Rs. 895,504/- for 47,201 units for the period from 08.11.2014 to 06.05.2015
 (06 months) in May 2015 due to some discrepancies pointed out in the incoming cable of the
 respondent during the site inspection dated 20.05.2015. The detection bill was challenged by the
 respondent before the Provincial Office of Inspection, Karachi Region-II, Karachi (POI) which was
 decided by POI vide its decision dated 11.11.2015.
- 2. K-Electric being aggrieved with the decision of POI dated 11.11.2015 has filed the instant appeal. During the hearing of the appeal and scrutiny of the record it is revealed that the appeal is filed against S. M. Naqvi and thereafter the name of Syed Mohammad appears in the bracket. Although the applicant before POI was S. M. Naqvi only but in the impugned decision as well as in the appeal name of Syed Mohammad is also appears in the bracket as the respondent. Obviously

impugned decision is ambiguous and makes it difficult to ascertain the actual respondent; to whom notice of the appeal could be issued.

3. For the foregoing reason, without going into the merits of the case, the impugned decision is struck down and the case is remanded back to POI for deciding the matter afresh by clearly indentifying the name of parties.
