#### **DECISION**

1. As per facts of the case, a person namely Rizwan filed an application before the Provincial Office of Inspection, Karachi Region-I, Karachi (POI) on 07.05.2014 and challenged the excessive bill of Rs. 26,524/ of March 2014 against the domestic connection bearing Ref. No. AL-701630 with sanctioned load of 5 kW under tariff

A-1R. The matter was disposed of by POI vide its decision dated 17.04.2017.

2. K-Electric being aggrieved with the decision of POI dated 17.04.2017 (impugned decision) has filed the instant appeal under Section 38 (3) of NEPRA Act 1997. It is noted that in the impugned decision as well as in the instant appeal, name of Muhammad Miskeen appears within brackets along with Rizwan as the respondent. This has created confusion in determining as to who is the actual respondent for issuing

3. In view of the above, without going into merit of the case, the impugned decision is set aside and matter is remanded back to POI for deciding the matter afresh clearly
