#### **DECISION**

- 1. Through this decision, an appeal filed by K-Electric against the decision dated 29.07.2016 of Provincial Office of Inspection, Karachi Region-I, Karachi (POI) is being disposed of.
- 2. Brief facts give rising to the instant appeal are that the respondent being aggrieved with the detection bills charged by K-Electric against the respondent filed a complaint before POI which was disposed of by POI vide its decision dated 29.07.2016.
- 3. K-Electric being dissatisfied with the impugned decision dated 29.07.2016 of POI has filed the instant appeal under Section 38 (3) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997. After issuing notice to both the parties, the appeal was heard in NEPRA Provincial Office Karachi on 30.01.2017 in which both the parties entered their appearance. At the outset of the hearing, the representatives of K-Electric disclosed that an out of court settlement was reached between the parties that relief already granted to the respondent to his satisfaction and that K-Electric was not interested to pursue its appeal before

NEPRA. The respondent also confirmed the amicable settlement.

4. In view of above, the appeal is dismissed as withdrawn.
