#### **DECISION**

- 1. Brief facts give rise to the instant appeal are that the respondent being aggrieved with the adverse actions of K-Electric including charging of disputed bill amounting to Rs. 1,625,515/for 73,002 units for the period from 06.05.2015 to 05.05.2016 and disconnection of supply, filed an application before Provincial Office of Inspection, Karachi Region-II, Karachi (POI) on 27.05.2016. The matter was decided by POI vide its decision dated 27.07.2016.
- 2. Being dissatisfied with the decision dated 27.07.2016 of POI, K-Electric has filed the instant appeal under Section 38 (3) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997. After issuing notice to both the parties, the matter was heard in NEPRA Provincial Office Karachi on 30.01.2017 in which both the parties were present. At the outset of the hearing, the representatives of K-Electric averred that K-Electric was not
