### **DECISION**

 Through this decision the appeal filed by K-Electric against the decision dated 28.09.2016 of Provincial Office of Inspection Karachi Region-II Karachi (hereinafter referred to as POI) is being disposed of. Brief facts of the case are that the respondent is an industrial consumer of K-Electric having sanctioned loaf of 5 kW and governed under tariff B-1. The respondent being aggrieved with a detection bill of Rs. 181704/-, for 9,350 units for the period 08.04.2015 to 07.04.2015 charged in December 2015 filed a complaint dated 06.04.2016 before POI. The matter was disposed by POI vide its

decision dated 28.09.2016 wherein the abovementioned detection bill was cancelled.

- The instant appeal has been filed by K-Electric against POI decision dated 28.09.2016. Notice of the appeal was issued to the respondent for filing reply/parawise comments but no reply/parawise comments were filed by the respondent.
- 3. After issuing notice, the hearing was held in Karachi on 10.04.2017 in which no one entered appearance for the respondent. Ms. Tatheera Fatima Deputy General Manager, the representative of K-Electric informed that an amicable settlement outside the court between the parties was arrived at and as such K-Electric was not interested to pursue the appeal before NEPRA. Subsequently this stance was confirmed by K-Electric vide it's email dated 12.04.2017.
- 4. Foregoing in consideration, the appeal is dismissed as withdrawn.
