#### DECISION

 Brief facts of the case are that the respondent is a commercial consumer of K-Electric having sanctioned load of 1 kW and governed under tariff A-2c. The respondent filed a complaint dated 08.12.2015 before Provincial Office of Inspection/Electric Inspector Karachi Region-I, Karachi (hereinafter referred to as POI) and challenged detection bill of Rs. 84,898/- of 3,148 units for the period 17.05.2015 to 16.11.2015. The complaint was disposed of by POI vide its decision dated 01.11.2016, whereof the aforementioned detection bill along with the Late Payment Surcharge (LPS) were declared as null &

void.

- 2. K-Electric being aggrieved with the POI decision dated 01.11.2016 (hereinafter referred to as the impugned decision) has filed the instant appeal under section 38 (3) of NEPRA Act 1997. Notice was issued to the parties and hearing of the appeal was held in Karachi on 28.04.2017. At the outset of the proceedings, Ms. Tatheera Fatima, the learned representative for K-Electric stated that the impugned decision dated 01.11.2016 was already implemented as such a request was made by K-Electric for withdrawal of the appeal.
- 3. In consideration of above, the appeal is dismissed as withdrawn.
