### **DECISION**

1. As per facts of the case, the Respondent who is a commercial consumer of K-Electric filed an application before the Provincial Office of Inspection, Karachi Region-I, Karachi (the POI) and challenged the difference bill of Rs.7,478,062/- for the cost of 1,381,413 units for the period March 2018 to July 2019 seventeen (17) months charged by the K-Electric in August 2019. The complaint of the respondent was disposed of by the POI vide decision dated 09.01.2020, wherein the above difference bill was cancelled and the K-Electric was directed to revise the same for two (2) billing cycles only.

- 2. Subject appeal has been filed against the above-referred decision by the K-Electric before the NEPRA. After issuing notice, hearing of the appeal was held at the NEPRA Reginal Office Karachi on 19.11.2021, which was attended by both the parties. At the outset of the hearing, the representatives for the K-Electric stated that the dispute of billing was amicably settled between the parties, as such the K-Electric did not intend to proceed further with the appeal. In support of its contention, the K-Electric submitted an application for withdrawal of the appeal. The Respondent seconded the statement of K-Electric representatives for mutual settlement between the parties.
- 3. In view of the above statement, the appeal is disposed of as withdrawn.
