### DECISION

1. As per facts of the case, the Respondent is a domestic consumer of K-Electric bearing Ref No.LC-403079 with sanctioned load of 1 kW and the applicable tariff category is A-1R. The Respondent filed an application before the Provincial Office of Inspection, Karachi Region-II, Karachi (the POI) and challenged the detection bill of Rs.45,045/- for 1.842 units for the period May 2019 to August 2019 charged by the K-Electric in October 2019. The complaint of the Respondent was disposed of by the POI vide decision dated 09.12.2020, wherein the above detection bill was cancelled.
2. Subject appeal has been filed against the above-referred decision by the K-Electric before the NEPRA. After issuing notice, hearing of the appeal was held at the NEPRA

Regional Office Karachi on 20.01.2022, which was attended by both the parties. At the outset of the hearing, the representatives for the K-Electric stated that the dispute of billing has amicably been settled between the parties, as such the K-Electric did not intend to proceed further with the appeal. The Respondent endorsed the statement of K-Electric representatives regarding mutual settlement between the parties.

3. In view of the above statement, the appeal is disposed of as withdrawn.
