DECISION

 As per facts of the case, the Respondent is a domestic consumer of K-Electric bearing Ref No.LC-137443 with sanctioned load of 2 kW and the applicable tariff category is A-1R. The Respondent filed a complaint before the Provincial Office of Inspection. Karachi Region-II, Karachi (the POI) on 11.06.2021 and challenged two detection bills i.e. first detection bill of Rs.46.946/- for 2,255 units for the period September 2019 to February 2020 and second detection bill of Rs.91.775/- for

September 2017. The complaint of the Respondent was disposed of by the POI vide decision dated 16.02.2022 (hereinafter referred to as the impugned decision). wherein the K-Electric was directed to cancel both the above detection bills.

- 2. Subject appeal has been filed against the above-referred decision by the K-Electric before the NEPRA. After issuing notice, hearing of the appeal was held at the NEPRA Reginal Office Karachi on 11.04.2022 in which the K-Electric representatives were present and no one appeared for the Respondent. At the outset of the hearing, the representatives for the K-Electric stated that the billing dispute was mutually settled between the parties, as such the K-Electric did not intend to proceed further with the appeal.
- 3. In view of the above statement of K-Electric, the appeal is disposed of as withdrawn.
