### **DECISION**


1. As per facts of the case, the Respondent is an industrial consumer of K-Electric bearing RefNo.AP-079450 with sanctioned load of 109 kW and the applicable tariff category is B-2b. The Respondent filed a complaint dated 11.08.2020 before the Provincial Office of Inspection, Karachi Region-II, Karachi (the "POI") and prayed (i) for withdrawal of arrears of Rs.481,969/- till January 2019, (ii) for refund an amount of Rs.640,824/- recovered in the bills for the period February 2017 to July 2017 and (iii) for revision of the bill for February 2020. The complaint of the

Respondent was disposed of by the POI vide decision dated 01.11.2021 (hereinafter referred to as the “impugned decision”), wherein the K-Electric was directed to charge the bills @ 2,829 units/month for the period February 2020 to April 2020 and refund of the excessive amount in the future bills.

2. Subject appeal has been filed against the above-referred decision by the K-Electric before the NEPRA. After issuing notice, hearing of the appeal was held at the NEPRA Regional Office Karachi on 04.03.2022, which was attended by the K-Electric representatives and no one appeared for the Respondent. At the outset of the hearing, the representatives for the K-Electric stated that the billing dispute was mutually settled between the parties, as such the K-Electric did not intend to proceed further with the appeal.
3. In view of the above statement of K-Electric, the appeal is disposed of as withdrawn.
