DECISION

1. As per facts of the case, Mr. Insaf Ali Sheikh (hereinafter referred to as the "Respondent") is a domestic consumer of K-Electric Limited (hereinafter referred to as the "Appellant") bearing Ref No.LA-978868 with a sanctioned load of 2 kW and the applicable tariff category is A-1(a). The Appellant debited a detection bill of Rs.115,371/- 5,026 units for

six months for the period from 28.08.2019 to 25.02.2020 to the Respondent on account of theft of electricity observed during checking dated 29.02.2020.

2. Being aggrieved, the Respondent filed a complaint before the Provincial Office of Inspection, Karachi Region-II, Karachi (the "POI"), and challenged the above detection bill. The complaint of the Respondent was disposed of by the POI vide decision dated 29.11.2022 in which the detection bill of Rs.115,371/- 5,026 units for six months for the period from 28.08.2019 to 25.02.2020 charged to the Respondent was cancelled.
3. Subject appeal has been filed against the above-referred decision of the POI (hereinafter referred to as the "impugned decision") by the Appellant before the NEPRA.

4. Proceedings by the Appellate Board

Notice dated 01.02.2023 was sent to the Respondent for filing reply/para-wise comments to the appeal within ten (10) days, which were filed by him on 10.02.2023.

5. Hearing

- 5.1 Hearing in the matter of the subject Appeal was fixed for 05.05.2023 at Karachi and accordingly, the notices dated 10.04.2023 were issued to the parties (i.e. the Appellant and the Respondent) to attend the hearing. As per schedule, the hearing of the appeal was conducted at the NEPRA Regional Office Karachi on 05.05.2023 in which both parties were present. During the hearing, the representatives for the Appellant declared that the matter of the disputed detection bill of Rs.115,371/- was amicably settled between the parties, and the revised bill of 1,500 units will be recovered from the

Respondent. The representatives for the Appellant prayed for the withdrawal of the appeal.

5.2 Conversely, the Respondent seconded the statement of the Appellant regarding the amicable settlement between the parties and pleaded for disposal of appeal accordingly.

6. In view of the above mutual settlement, the appeal is disposed of as withdrawn.
