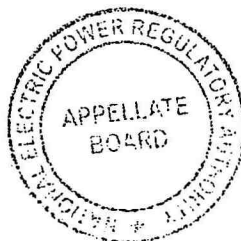
## **DECISION**

1. As per the facts of the case, Mr. Muhammad Tariq (hereinafter referred to as the “Appellant”), who is a domestic consumer of K-Electric (hereinafter referred to as the “Respondent”) bearing Ref No. LC-340379 filed a complaint before the Provincial Office of Inspection, Karachi Region-II, Karachi (the “POI”) and challenged the arrears of Rs.120,148/-accumulated till August 2019.
2. The complaint of the Appellant was disposed of by POI vide decision dated 16.03.2023 against which subject appeal has been filed by the Appellant before the NEPRA. After issuing notices, the hearing was conducted at the NEPRA Regional Office Karachi on 06.11.2023 which was attended by both parties. At the outset of the hearing, the representatives for the Respondent stated that the matter was amicably settled between the parties and a rebate of Rs.78,000/- against the impugned arrears of Rs.120,148/- has already been afforded to the Appellant in April 2023.
