DECISION

1. Briefly speaking, Mr. Irfan Alam Farooqui (hereinafter referred to as the “Respondent”) is a domestic consumer of K-Electric (hereinafter referred to as the “Appellant”) bearing Ref No. 0400003589100 (LA-415816) having sanctioned load of 05 kW and the applicable tariff category is A-1R. The Appellant challenged the following bills before the Provincial Office of Inspection Karachi Region-II, Karachi (the “POI”):

- Detection bill of Rs.157,862/- against 7,388 units for six months for the period from 17.12.2017 to 19.06.2018 to the Respondent.
- Assessed bills for July 2016, May 2017, June 2017, January 2018 and July 2018.

2. The complaint of the Respondent was disposed of by POI vide decision dated 27.06.2022 against which subject appeal has been filed by the Appellant before the NEPRA.
