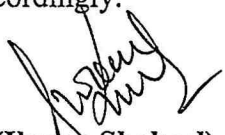

ORDER

1. Brief facts of the case are that Syed Haris Masood (the “Respondent”) is a domestic consumer of K-Electric Limited (the “Appellant”) bearing Ref. No.0400016515677 with a sanctioned load of 01 kW, and the applicable tariff category is A-1R. The Respondent filed an application before the Provincial Office of Inspection, Karachi Region, Karachi (the “POI”) and challenged the detection bill of Rs.185,660/- for 754 units for the period 04.02.2024 to 05.08.2024. The POI vide decision dated 18.06.2025 cancelled the above detection bill and directed the Appellant to charge the bill for 57 units only, against which subject appeal has been filed by the Appellant before NEPRA under Section 38(3) of NEPRA Act.
2. After issuing notices, a hearing in the matter was conducted at NEPRA Regional Office Karachi on 27.09.2025, wherein representatives for the Appellant tendered appearance, whereas no one represented the Respondent. At the outset of the hearing, the representatives for the Appellant stated that the POI decision dated 18.06.2025 has been implemented in true spirit, as such, the Appellant does not intend to proceed with the appeal.
3. In view of the above statement, the appeal is disposed of.
