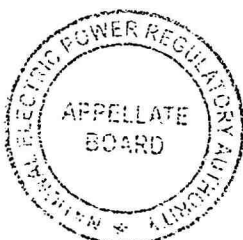

DECISION

1. As per facts of the case, M/s. E-vision Manufacturing Ltd (hereinafter referred to as the "Respondent") is an industrial consumer of LESCO (hereinafter referred to as the "Appellant") bearing Ref No.24-11223-1000860 U with a sanctioned load of 490 kW and the applicable tariff category is B-2(b). The Respondent challenged the detection bill of Rs.5,509,917/- for 286,985 units+584 kW MDI for the period from June 2019 to August 2020 before the Provincial Office of Inspection, Lahore Region, Lahore (the "POI") on 27.10.2020. The complaint of the Respondent was disposed of by the POI vide decision dated 05.08.2021 against which the subject appeal was filed by the Appellant before the NEPRA.

2. Hearing
