### **DECISION**

1. Brief facts of the case are that Mr. Muhammad Tazeen (the “Respondent”), who is an industrial consumer of Lahore Electric Supply Company Limited (the “Appellant”) bearing Ref No. 46-11114-13409900-U filed a complaint before the Provincial Office of Inspection, Lahore Region, Lahore (the “POI”) and challenged the detection bill of Rs.3,946,974/- for 183,605 units for the period from November 2016 to March 2019 debited by the Appellant. The complaint of the Respondent was disposed of by the POI vide decision dated 15.06.2021 against which the subject appeal was filed by the Appellant before the NEPRA.
2. Hearing was conducted at NEPRA Regional Office Lahore on 19.01.2024, wherein both the parties tendered appearance. At the outset of the hearing, learned counsel for the Appellant stated that the impugned decision dated 15.06.2021 of the POI has been implemented, as such the Appellant does not intend to press this Appeal anymore. Learned counsel for the Respondent seconded the statement of the Appellant regarding the implementation of the impugned decision dated 15.06.2021 of the POI.
3. In view of the above statement, the appeal is disposed of as withdrawn.
