DECISION

1. Briefly speaking, Punjab Auqaf Organization (the "Respondent"), who is general supply consumer of Lahore Electric Supply Company Limited (the "Appellant") bearing Ref No.24-11253-0015812-U filed a complaint before the Provincial Office of Inspection, Lahore Region, Lahore (the "POI") and challenged the bills for the periods from February 2017 to November 2017 and from January 2018 to May 2019. The complaint of the Respondent was disposed of by the POI vide decision dated 05.05.2023 against which the subject appeal was filed by the Appellant before the NEPRA.
2. Hearing was conducted at NEPRA Regional Office Lahore on 01.03.2024, wherein both the parties tendered appearance. At the outset of the hearing, the Appellant declared that the matter of the disputed bill is amicably settled between the parties, as such the Appellant does not intend to press this Appeal anymore. Learned counsel for the Respondent seconded the statement of the Appellant regarding the amicable settlement of disputed bills.
3. In view of the above statement, the appeal is disposed of as withdrawn.
