

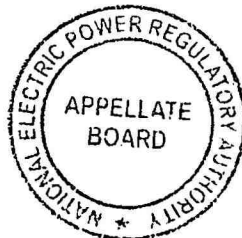

DECISION

1. Brief facts of the case are that M/s. Dubai Islamic Bank (hereinafter referred to as the "Respondent"), who is a commercial consumer of Lahore Electric Supply Company Limited (hereinafter referred to as the "Appellant") bearing Ref No.24-11216-9150000-U filed a complaint before the Provincial Office of Inspection, Lahore Region, Lahore (hereinafter referred to as the "POI") and challenged the detection bill of Rs.4,049,677/- charged in October 2022. The complaint of the Respondent was disposed of by the POI vide decision dated 15.06.2023 and the above-referred impugned detection bill was cancelled. The Appellant preferred instant appeal before NEPRA against the impugned decision dated 15.06.2023 of the POI.
2. Hearing was conducted at NEPRA Regional Office Lahore on 07.06.2024, wherein both parties tendered appearance. At the outset of the hearing, the representative for the Respondent averred that the Appellant implemented the impugned decision and afforded credits of Rs.2,759,324/- and Rs.1,493,110/- in June 2023 and August 2023 respectively. In support of his contention, the representative for the Respondent submitted the billing statement showing the aforesaid credits. On the other hand, the learned counsel for the Appellant assured to submit a confirmation letter from the concerned Revenue Officer of the Appellant within seven working days. Subsequently, the Appellant stated that the matter of the disputed bill has been amicably settled between the parties, as such the Appellant does not intend to press this Appeal anymore. In support of his contention, learned counsel for the Appellant submitted a copy of

the letter conveyed by the Revenue Officer of the Appellant, wherein he seconded the statement of the Respondent regarding the aforesaid rebate given to the Respondent in June 2023 and August 2023.

3. In view of the above statement, the appeal is disposed of.
