

## **DECISION**

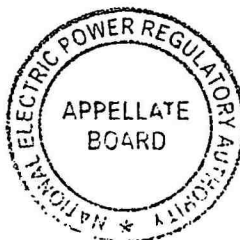
1. As per facts of the case, Mr. Abdul Khalid (hereinafter referred to as the “Respondent”), who is an industrial consumer (ice factory) of Multan Electric Power Company Limited (hereinafter referred to as the “Appellant”) bearing Ref No.27-15125-2503600-R filed a complaint before the Provincial Office of Inspection, Multan Region, Multan (the “POI”) and challenged the detection bill of Rs.287,867/- against 13,200 units charged in May 2019. The complaint of the Respondent was disposed of by the POI vide decision dated 14.02.2020 against which the subject appeal was filed by the Appellant before the NEPRA.

## **2. Hearing**

Hearing was conducted at the NEPRA Regional Office Multan on 09.01.2024, wherein both parties were in attendance. At the outset of the hearing, the Appellant declared that the matter of the disputed bill is amicably settled between the parties and the Respondent is ready to pay the outstanding arrears, as such the Appellant does not intend to press this Appeal anymore. support of his contention, the Appellant placed the written application regarding the amicable settlement of the disputed bill. The Respondent appearing in person seconded the statement of the Appellant regarding the amicable settlement of disputed arrears.

3. In view of the above statement, the appeal is disposed of as withdrawn.
