

DECISION

1. Brief facts of the case are that the appellant is an industrial consumer of Peshawar Electric Supply Company Limited (PESCO) bearing Ref No.30-26442-0001810 having a sanctioned load of 72 kW under the B-2b tariff. SDO PESCO approached the Provincial Office of Inspection (POI) vide letter No.181-182 dated 17.01.2018 for checking the accuracy of the meter of the appellant. Therefore the Automatic Meter Reading (AMR) billing meter of the appellant and its downloaded data was checked by POI and reportedly 33% slowness was established. POI vide its decision dated 29.03.2018 allowed PESCO to recover 33% slowness of the meter for the period 13.05.2015 to 04.01.2017 from the appellant. Subsequently, the appellant received the

bill of August 2019 amounting to Rs.1,414,328/-, which contained the above detection bill.

2. Through the instant appeal, the POI decision dated 29.03.2018 has been assailed. The appeal was heard in NEPRA head office Islamabad on 10.12.2019 in which the appellants were in attendance but there was no representation by the respondent PESCO. At the outset of the hearing, the appellant informed that they are not interested to proceed with the appeal and prayed for its withdrawal.
3. In view of the above, the appeal is dismissed as withdrawn.
