

DECISION

- 1. As per the facts of the case, M/s. Usmania Restaurant (hereinafter referred to as the "Respondent"), who is a commercial consumer of Peshawar Electric Supply Company Limited (hereinafter referred to as the "Appellant") bearing Ref No.30-26133-0012002 filed a complaint before the Provincial Office of Inspection, Peshawar Region, Khyber Pakhtunkhwa (the "POI") on 21.12.2022 and challenged the detection bill of 5,748 units charged on account of theft of electricity. The complaint of the Respondent was disposed of by the POI vide decision dated 28.02.2023 against which the subject appeal was filed by the Appellant before the NEPRA.
- 2. Hearing was conducted at the NEPRA Regional Office Peshawar on 17.03.2025, wherein both parties tendered appearance. At the outset of the hearing, the representative for the Appellant disclosed that the impugned decision of POI has been implemented in true spirit and credit of Rs.209,028/- was afforded in the bill for November 2024, as such the Appellant does not intend

to press the appeal. Accordingly, the Appellant submitted a written request dated 17.03.2025 before the NEPRA for withdrawal of the appeal. The representative for the Respondent seconded the statement of the Appellant regarding the implementation of the impugned decision.

3. In view of the above statement, the appeal is disposed of as withdrawn.
