SUBJECT: DECISION IN THE MATTER OF COMPLAINT FILED BY M/S ZONG CMPAK THROUGH MR. AYAZ AHMED UNDER SECTION 39 OF THE REGULATION OF GENERATION, TRANSMISSION AND DISTRIBUTION OF ELECTRIC POWER ACT, 1997 AGAINST FESCO REGARDING WRONG BILLING.

DECISION

This decision shall dispose of the complaint filed by M/s Zong CMPak through Mr. Ayaz Ahmed (hereinafter referred to as the "Complainant") against Faisalabad Electric Supply Company (hereinafter referred to as the "Respondent" or "FESCO") under Section 39 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the "NEPRA Act").

Brief facts of the case are that the Complainant in the complaint submitted that the actual consumption being recorded on the meter located at the site owned by another cellular company i.e. M/s Deodar Limited is being wrongly reflected against the connection owned by M/s Zong CMPak and vice versa. The Complainant requested to adjust the disputed bills as per actual consumption at the site. The matter was taken up with FESCO and hearings were held at NEPRA Regional Office, Faisalabad whereby the matter was discussed in attendance of all the parties including the representative of M/s Deodar Limited.

During the hearing, all the parties including FESCO agreed to transfer the actual units charged to the Complainant's connections having reference number i.e. $(27-13162_5 3001722)$ during the period October, 2022 to September, 2023 to the connection of M/s Deodar Limited under reference number (27-13162-3001714) & vice versa after adjusting the already charged units of each connection during same period. However, considering anticipated quantum of the chargeable units to connection of M/s Deodar Limited and on request of the representative of M/s Deodar Limited, it is of considered approach to allow installments in bill of M/s Deodar Limited.

4. Foregoing in view, FESCO is directed to overhaul/revise the electricity bills of both the connections in accordance with the above conclusion. Moreover, FESCO is directed to allow monthly installments in the bill of M/s Deodar limited having reference number (27-13162-3001714). Compliance report be submitted within twenty (20) days.
