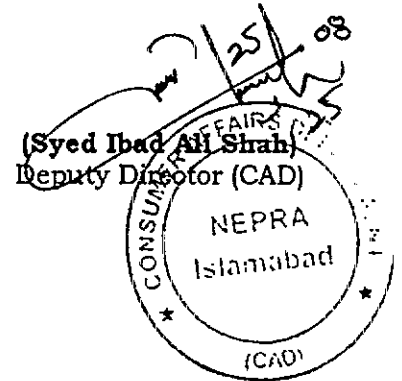

**Subject:** **DECISION IN THE MATTER OF REVIEW MOTION FILED BY K-ELECTRIC LIMITED AGAINST THE DECISION OF NEPRA IN THE MATTER OF COMPLAINT FILED BY MR. MOHSIN MOTIN UNDER SECTION 39 OF THE REGULATION OF GENERATION, TRANSMISSION AND DISTRIBUTION OF ELECTRIC POWER ACT, 1997 AGAINST K-ELECTRIC LIMITED REGARDING WRONG BILLING (ACCOUNT NO. 0400011497727).**

Through this decision, a motion for leave for review filed by K-Electric Limited (hereinafter referred to as the "Petitioner" or "KE") against the decision of NEPRA Regional Office Karachi dated January 02, 2025 in the matter of complaint of Mr. Mohsin Motin (hereinafter referred to as the "Complainant") against K-Electric Limited filed under Section 39 Of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the "NEPRA Act"), is being disposed of.

2. Brief facts of the case are that NEPRA received a complaint wherein the dispute agitated by the Complainant was that KE has charged excessive bill for the month of July

2024 and requested NEPRA to intervene in the matter and direct KE to revise the excessive bill. The matter was taken-up with KE for submission of para wise comments/report. In response, KE reported that the bills have been issued to the complainant on the basis of actual meter reading recorded through energy meter installed at the Consumer premises. The report of KE was sent to the Complainant for information/comments. The Complainant raised observations over the report of KE

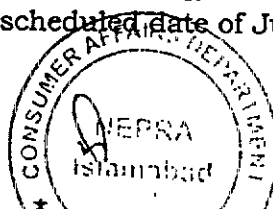
3. In order to proceed further into the matter, hearings were held at NEPRA Regional office Karachi which were attended by both the parties i.e. the Complainant and representative of KE. During the hearing, representatives of KE informed that KE has charged bill to the Complainant for the month of July 2024 on meter reading date July 09, 2024, whereas KE has charged bill for the month of June, 2024 on meter reading date June 08, 2024 (for 31 days). The case was analyzed in detail in light of written/verbal arguments of the parties, documents placed on record and applicable law. Accordingly, K-Electric was directed to revise bill for the month of July 2024 on the basis of pro rata consumption considering 30 days billing cycle.

4. Being aggrieved with the decision of NEPRA Regional Office Karachi, K-Electric filed a motion for leave for review. K-Electric in its review inter-alia submitted as under:

- i. The bill for the month of July 2024 was issued to the Complainant based on billing period of 31 days as per the number of days in the calendar month of July 2024 and the same is consistent with definition of "billing period" as defined in the NEPRA approved tariff terms and conditions.
- ii. The consumption recorded during the billing month of July 2024 was equal to 206 units hence the Complainant cannot be categorized as a protected consumer.
- iii. The meter reading was indeed carried out on the same date i.e. July 09, 2024 as such proration will have no impact on units charged to the consumer as well as applicable tariff category.


5. The motion for leave for review filed by K-Electric was considered and accordingly, a hearing was held in presence of both the parties at NEPRA Office, Karachi. The following has been concluded:

- i. The instant matter pertains to the monthly bill charged by KE to the Complainant for the month of July 2024 having tariff category A1R on connection bearing account No. 0400011497727.
- ii. The Complainant is of the view that KE has charged bill for the month of July 2024 on higher side which caused shifting from protected to unprotected tariff category.
- iii. KE is of the view that KE has charged bill to the Complainant on the basis of actual meter reading recorded through energy meter installed at the Consumer premises as per meter reading scheduled date of July 09, 2024.



- iv. As per tariff notified vide SRO.1035(1)/2024 month or billing period unless otherwise defined for any particular tariff category means a billing month of 31 days or less reckoned from the date of last meter reading. Moreover, the said SRO has been effective since July 1, 2024.
- v. KE has charged bill to the Complainant for the month of July 2024 with meter reading date as July 09, 2024 for 31 days period as meter reading for the month of June 2024 was carried by KE on June 08, 2024.
- vi. KE has charged bill to the Complainant for the month of July 2024 in line with the provision defined in the above mentioned SRO.

6. Foregoing in view, the decision of NEPRA Regional Office, Karachi dated January 02, 2025 is modified and it is held that the bill for the month of July 2024 charged by KE to the Complainant is justified. Further proceedings in the matter are being closed by this office.
