

Subject: **DECISION IN THE MATTER OF COMPLAINT FILED MR. ASIF KHAN AKHTER**  
**UNDER SECTION 39 OF THE REGULATION OF GENERATION,**  
**TRANSMISSION AND DISTRIBUTION OF ELECTRIC POWER ACT, 1997**  
**AGAINST K-ELECTRIC LIMITED REGARDING DETECTION BILL**  
**(CONSUMER No. LA-582745 & LC-063934)**

This decision shall dispose of the Complaint filed by Mr. Asif Khan Akhter, H. No. A-117, Gali No. 5, Bakhtawar Goth, Gulistan-e-Jauhar, Karachi, (hereinafter referred to as "the Complainant") against K-Electric Limited (hereinafter referred to as the "Respondent" or "KE"), under Section 39 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the "NEPRA Act").

2. Brief facts of the case are that NEPRA received a complaint wherein the dispute agitated by the Complainant was that KE has charged detection bill and requested NEPRA to intervene in the matter & direct KE to withdraw the detection bills. The matter was taken-up with KE for submission of parawise comments/report. In response, KE reported that a discrepancy of extra phase in use was reported. KE added that the consumer has been charged detection bills amounting to Rs.137,395/- & Rs.227,843/- on the connections bearing consumer No. LA-582745 & LC-063934 respectively. The report of KE was sent to the Complainant for information/comments. The Complainant raised observations over the report of KE.

3. In order to proceed further into the matter, several hearings were held at NEPRA Regional office Karachi on which was attended by both the parties i.e. (KE and the Complainant) in person wherein the matter was discussed in detail.

4. The case has been examined in detail in light of the record made so available by the parties, arguments advanced during the hearing and applicable law. The following has been observed:

- i. The instant matter pertains to charging of detection bills amounting to Rs.137,395/- & Rs.227,843/- on the electricity connection having consumer no. LA-582745 & LC-063934 respectively having tariff A1R.
- ii. KE is of the view that the detection bills amounting to Rs.137,395/- & Rs.227,843/- for the period from April 2024 to September 2024 have been charged against the discrepancy of light direct in use on connected load of 4kW on the connections having consumer No. LA-582745 & LC-063934 respectively.
- iii. KE showed sufficient evidence against the above mentioned detection bills. Moreover, electricity consumption on the said connection has observed to be on lower side as compared as compared the connected load of the premises.
- iv. Further it has observed that KE has charged the said detection bills on higher side.

5. Foregging in view, KE is directed to revise the detection bills amounting to Rs.137,395/- & Rs.227,843/- charged to the Complainant on LA-582745 & LC-063934 respectively from six (06) months to three months. A report in this regard be submitted within twenty (20) days, positively.
