## DECISION

This decision shall dispose of the complaint filed by Mr. Dost Muhammad (hereinafter referred to as "the Complainant") against Lahore Electric Supply Company Limited (hereinafter referred to as the "Respondent" or "LESCO"), under Section 39 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the "NEPRA Act").

2. The Complainant in his complaint submitted that LESCO has charged him an illegal detection bill. Accordingly, the matter was taken up with LESCO and a hearing was held on May 09, 2024 at NEPRA Provincial Office, Lahore. The hearing was attended by both the parties (i.e., LESCO and the Complainant) wherein the matter was discussed in detail. During the hearing, it was revealed that on December 30, 2023, LESCO staff, during the surveillance, found the complainant involved in using direct supply from main LT line. Subsequently, LESCO charged a detection bill of 851 units to the Complainant during the month of March, 2024 on the basis of connected load (i.e., 3.031 kW) for the period of three (03) months w.e.f. October, 2023 to December, 2023.

3. Clause 9.1.3 of NEPRA Consumer Service Manual (CSM) provides that "DISCO shall be authorized to recover its loss by raising a detection bill as follows provided that the maximum period of charging in such cases shall be restricted to twelve months for unregistered consumers and up to six months for registered consumers". Whereas clause 9.1.3 (b) provides that "Detection Bill for Registered Consumers; The detection bill shall be issued as per the following methods in the order of priority:

(i) Previous consumption/Billing History

(ii) On the basis of future undisputed consumption if no previous credible consumption is available.

(iii) No of detection units = Load x Load Factor x 730 x Months Where:

Load means the connected load or sanctioned load in kW whichever is higher Months = Period for charging detection bill Load Factor as per Annexure-V 730 = Average number of hours in a month

4. In the instant case, the Complainant has been charged with detection bill on the basis of connected load (i.e., 3.031 kW) instead of previous healthy consumption/billing history. Therefore, detection bill is required to be revised on previous consumption/billing history as per NEPRA CSM.
