In pursuance to the Order of Honorable High Court, Lahore dated February 20, 2024, in Writ Petition No. 11144/2024, this decision shall dispose of the complaint filed by Mr. Munir Ahmad S/o Muhammad Ramzan, Village Dahar Hujra Shah Muqeem (hereinafter referred to as the "Complainant") against Lahore Electric Supply Company Limited (hereinafter referred to as the "Respondent" or "LESCO"), under Section 39 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the "NEPRA Act").

2. The Honorable Lahore High Court, Lahore in Writ Petition No. 11144/2024 directed NEPRA to pass a decision on the petitioner's representation. Accordingly, a hearing was conducted on March 06, 2024 which was attended by the representative of the Complainant only whereas LESCO officials assured to adjust the bill and submit report to this office within two (02) weeks. In view of the said, LESCO has submitted report vide letter No. 2721-23 dated April 01, 2024 whereby it has been informed that the bill of the Complainant has been revised and the issue of the Complainant has been resolved.

3. In view of the said, further proceedings in the matter are being closed by this office.
