#### **DECISION**

This decision shall dispose of the complaint filed by Mr. Navid Akhtar (hereinafter referred to as the "Complainant") against Lahore Electric Supply Company Limited (hereinafter referred to as the "Respondent" or "LESCO") under Section 39 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (hereinafter referred to as the "NEPRA Act").

- 2. NEPRA received a complaint wherein it was submitted that the Complainant was charged an illegal detection bill by LESCO during month of February, 2025. Upon approaching LESCO, the grievances remained unaddressed and consequent to above, matter was escalated to NEPRA, seeking review of detection bill. Accordingly, the matter was taken up with LESCO for submission of detailed para-wise comments/report. In response, LESCO vide a letter dated February 19, 2025 submitted that the detection bill of 2950 units was charged against the Complainant's account as the Complainant was found involved in direct theft of electricity. The LESCO's report was forwarded to the Complainant, however, the Complainant challenged the report by submitting a rejoinder dated March 14, 2025.
- 3. In order to probe further into the matter, a hearing was held on April 22, 2025 at NEPRA Provincial Office, Lahore which was attended by representatives of both the parties wherein the matter was discussed at length. The case has been examined in detail in the light of written/verbal arguments of both the parties and applicable law. The following has been concluded.
  - i. The Complainant's residential connection installed against reference number i.e. 02-11535-0900804, was charged detection bill of 2950 units by LESCO during February 2025 on account of alleged usage of direct supply. The Complainant was of the view that the detection bill was charged by LESCO with mala fide intent.
  - ii. Perusal of the documentary evidence reveals that the detection bill was charged to the Complainant for period of three months i.e. November, 2024 to January 2025 based on the connected load i.e. (6.9) kW while the same is inconsistent with clause

9.1.3 of Consumer Service Manual (CSM) for charging detection bill in case of direct theft of electricity by registered consumer as per which detection bill can be charged in an order of priority i.e. previous consumption history etc. which has not been followed by LESCO.

- iii. The analysis of Complainant's billing history reflects a regular and nominal pattern of electricity consumption, with no significant dip. Moreover, the impugned detection bill of 2950 units appears to be unjustified, as the same was calculated based on an excessive connected load of 6.9 kW in comparison with the sanctioned load, which is not supported by the consumption trend. It is of note that the connection was only installed during October, 2024.
- iv. Moreover, LESCO officials failed to provide any concrete video or pictorial evidence establishing the alleged theft, in noncompliance with clause 9.1.4 of CSM. Hence, the frivolous detection bill charged for the excessive load of 6.9 kW, and checking performed by LESCO only during February, 2025, inconsiderate of none prior theft incidents recorded against the Complainant, is devoid of any merits and is required to be withdrawn.
- 4. Foregoing in view, LESCO is directed to withdraw the aforementioned detection bill of 2950 units charged to the Complainant during February, 2025. Compliance report be submitted to this office within fifteen (15) days.
