Subject: AUTHORITY PROPOSED MODIFICATION (APM) IN THE GENERATION LICENSE (NO. GL/02/2002, DATED JULY 01, 2002) OF CPGCL/GENCO-II

Reference: NEPRA Office Letter No. NEPRA/D (Lic)/LAG-02/18243, December 28, 2015
No. CPGCL/CEO/MIS/15/19630-36, 18-12-2015

This is regarding the Authority Proposed Modification in the Generation License of CPGCL, in the context of your letter number cited under reference [1]. Unit No. 3 is being operated, on requirement of the System Operator, beyond its 30-years commissioning life to meet the electric power system requirement.

So far, the unit is being operated only on gas fuel, even today the unit is contributing 140MW on the power grid. Its present efficiency is 25.8% and generation cost is RS 7.95 per kWh, including establishment and other charges [Ref:2, e-form November 2015]. As a ground reality, presently because of the low Hydel indents and low system contingencies on 500kV network, Unit No. 3 supports the system through 220kV grid in limiting the power shortages.

Therefore, it is requested to please allow to keep the unit in operation at least for a period of 2-3 years as an emergency option for the System Operator and requests for consideration of the same to the NEPRA.

In view of the above, the Authority Proposed Modification in the Generation License of CPGCL/GENCO-II is denied and may please be withdrawn.
