Subject: **REVISED APPLICATION FOR POWER DISTRIBUTION LICENSE FOR PUNAJAB INDUSTRIAL ESTATE DEVELOPMENT AND MANAGEMENT COMPANY (PIEDMC) OWNED BY GOVT. OF PUNJAB AT SUNDAR INDUSTRIAL ESTATE.**

In continuation to this office Ref: No. PIE/NEPRA/6304 dated 25 Sep 2006 Ref: No. PIE/NEPRA/12100, dated 06th Nov 2008 and visit of PIE representative to NEPRA Office dated 15-01-2011, we submit a revised application amended as below:

1. I, Maj. General Retired Javed Iqbal, Chief Executive Officer, being duly authorized representative of Punjab Industrial Estates Development and Management Company (PIEDMC) Sundar by virtue of power of Attorney / Board Resolution as stipulated in its 34th BOD Meeting dated 27-01-2009 hereby; and make the amendment in memorandum and article association of Punjab industrial Estate Development and Management Company on dated 20 Oct, 2010 for Generation, distribution and Transmission of Electric Power as clause X. placed as Annexure-1 hereunder.
 - (i) apply to National Electric Regulatory Authority, Islamabad, for the grant of Distribution License to the Punjab Industrial Estates Development and Management Company (PIEDMC) Govt. of Punjab within Sundar Industrial Estate, pursuant to section 20 of the regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997).
 - (ii) PIEDMC is currently taking 36MW load and plans to get additional electric power, as and when required according to attached schedule also submitted to LESCO up to 204MW; from Lahore Electric Supply Company, Lahore under B4 tariff and then distributing it to the mixed load consumers within Sundar Industrial Estate with a probable expansion plan placed as Annexure-2 hereunder
2. With reference to the LESCO letter # 2140/GM (Tech)/LESCO/PA they say no to give any electrical connection in the vicinity of Sundar Industrial Estate.

So, as per your office letter # NEPRA / R/LAD-11/PIEDMC/7041-42 at Oct 17, 2006 "in case LESCO is unable to provide service connection to Sundar Industrial Estate, the Authority can consider your case as a new in-set distribution company" with the above reference we are re-submitting our application.
4. It is further intimated that since LESCO has failed to give NOC to PIEDMC for its Distribution License within Sundar Industrial Estate, inspite of its repeated requests, it also tried to get the existing B4 tariff changed to C3 (b) that LESCO failed even to response so far; the NEPRA may, by invoking its powers under Section 26, issue the subject License to PIEDMC, Lahore.
5. A bank draft / pay in the sum of Rupees 1,302,100\/- being the 'Non-refundable License Applicant Fee calculated in accordance with schedule II of the National Electric Power Regulatory Authority Licensing (Application and Modification Procedure) Regulations, 1990, is attached here with for the above 50MW Distribution License.
6. Table of Contents, detail of Annexure and other particulars for New Facility are attached here to complete the 'License Application'.
