





**DECISION OF THE AUTHORITY IN THE MATTER OF MOTION FOR LEAVE FOR

AUTHORITY DECISION DATED MARCH 10, 2015 PERTAINING TO THE FY 2014-15**


The Consumer-End Tariff pertaining to the FY 2014-15 for Peshawar Electric Supply Company Limited, hereinafter called "the PESCO", was determined by the Authority vide its determination dated 10th March, 2015. Against the said determination the PESCO has filed a motion for leave for review.



3. During the pendency of proceedings the PESCO requested for the withdrawal of its motion for leave for review vide letter No 252-53/FD/PESCO/CP&C dated 15th May, 2015.
4. Considering the fact that the PESCO is no more interested in pursuing the motion for leave for review, the motion for leave for review is accordingly dismissed as withdrawn.


