DECISION OF THE AUTHORITY IN THE MATTER OF POLICY GUIDELINES FORWARDED BY THE MINISTRY OF ENERGY (MOE) UNDER SECTION 31 OF REGULATION, GENERATION, TRANSMISSION DISTRIBUTION OF ELECTRIC POWER ACT, 1997 FOR RE-TARGETING POWER SECTOR SUBSIDIES- PHASE-II

The Authority on its own motion has noticed that a clarification is required in its decision dated March 09, 2022 issued vide No. NEPRA/R/ADG(Tariff)/TRF- 100/3749-3851 in the matter of Policy Guidelines forwarded by the Ministry of Energy (MoE) under Section 31 of Regulation, Generation, Transmission Distribution of Electric Power Act, 1997 for Re-Targeting Power Sector Subsidies- Phase-II. Accordingly, the Authority has decided to issue the following clarification by issuing this decision, whereby, the following amendments are being made;

- ✓ In Annex-C and D, under Table A-1 General Supply Tariff- Residential, the word "for the Applicable Variable Charges" shall be added at the end of first line.
- ✓ In Annex-III of each DISCO, under Table A-1 General Supply Tariff- Residential, the word "only protected" shall be omitted from the first line and the following shall be added at the end; "As per Authority's decision for one slab benefit in the unprotected residential consumers category slabs, from 301-700, the slab rates of 201-300 slab would be used for previous slab benefit up-to 300 units."
