#### Corrigendum

Islamabad, the May 8, 2023

In SRO No. 497(I)/2023 dated 17.04.2023, the para 2 may be read as under:

"The above adjustment of decrease of (Rs.0.0006/kWh) shall be applicable to all the consumer categories except life line consumers, domestic consumers consuming up-to 300 units, Electric Vehicle Charging Stations (EVCS) and Agriculture consumers of all the XWDISCOs. It is hereby clarified that negative adjustment on account of monthly FCA is also applicable to the domestic consumers having Time of Use (ToU) meters irrespective of their consumption level. The said adjustment shall be shown separately in the consumers' bills on the basis of units billed to the consumers in the month of February 2023. XWDISCOs shall reflect the fuel charges adjustment in respect of February 2023 in the billing month of April 2023".
