In continuation of this office letter No. NEPRA/TRF-100/IPI/7590-7592 dated August 22, 2011 whereby Decision of the Authority with respect to Import of Power from Iran First Amended Restated Contract with Tavanir was sent to the Federal Government for notification in the official Gazette.

Approval of Extension of Tariff effective from 1st January 2014 to 31st December 2014 in Contract dated 6th November 2002 between NTDC and TAVANIR, Iran for Supply of 74 MW

1. NTDC vide letter No. GM (WPPO)/NTDC/7769-71 dated 9.9.2014 submitted that the NEPRA approved tariff vide letter No. NEPRA/TRF-100/IPI/7594 dated 22.8.2011 has been expired on 31st December 2013. According to NTDC the same agreed tariff and terms and conditions allowed by NEPRA has been extended for one more year (upto 31st December 2014) by mutual agreement with TAVANIR. NTDC submitted that as per requirement of the TAVANIR, the extension needs to be done through Amendment No. 3 to the Contract dated December 2002 between WAPDA & TAVANIR. NTDC along with the request provided the copies of the approval of the Board of Directors dated 25.3.2014 and ECC's decision dated 26.8.2014.
2. The Authority considered the request submitted by NTDC. Since NTDC's request does not require any change / modification in the NEPRA allowed tariff and terms and conditions dated 22.8.2011, the Authority has therefore decided to accord approval in extension of the allowed tariff from 1st January 2014 to 31st December 2014 through approving the amendment No. 3 submitted by NTDC.
