## **CORRIGENDUM**

## DETERMINATION OF THE AUTHORITY IN THE MATTER OF UPFRONT GENERATION TARIFF FOR IMPORTED/LOCAL COAL POWER PLANTS DATED 26-06-2014

- Following corrections have been made in the decision of the Authority issued vide No. NEPRA/TRF-**IT**TC/2013/7195-7197 dated June 26, 2014 in the matter of upfront tariff for coal power projects:
- i. In Para 54 on page 18 in line 6 and 8, the figure "8%" may be replaced with "9%".
- ii. Under Para 56(II)(ii)(a) on page 23 in row 2 of column 2, the figure "322" may be replaced with "318.5".
- iii. Under Para 56(II)(v) on page 24 the word **"220MW"** may be replaced with **"220MW/350MW"**.
- iv. At Para 56(II)(xviii)(a) on page 29 in column 1 of row 2, the figure "322" may be replaced with "318.5".
- v. In the attached annex 17, on page 73 of the above referred determination, under assumptions in row 2 of column 3, the figure "322" may be replaced with "318.5"
